- Agree to international consultation with CRIRSCO NROs prior to amending its reporting standard
- Include self regulating professional bodies with disciplinary power and codes of ethics
- Engage in CRIRSCO activities

 - Number of members not limited
- Process
 - NRO applies for membership
 - CRIRSCO assists with process

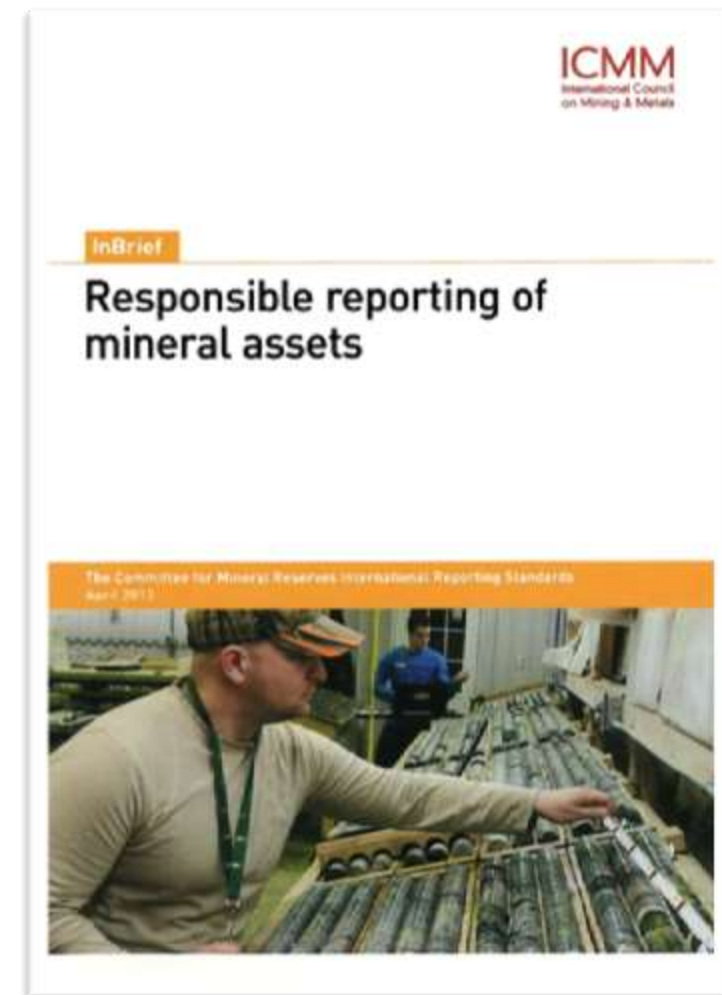


Annual General Meeting

- Potential new members invited as observers
- Interested parties invited to Open Session
- Decision making by consensus
- Goal – United voice related to Reporting of Mineral Exploration Results, Mineral Resources and Reserves

- Formed on an as needed basis
- Deal with specific issues related to CRIRSCO activities
- Current Committees
 - United Nations Framework Committee (UNFC) – Expert Group on Resource Classification
 - International Accounting Standards Board (IASB)

- 2007 – Association with International Council on Mining and Metals
- Strategic Partners
- ICMM provides financial and administrative support
- Promote activities of each other



- Programs and budgets developed annually
- Observer status with International Seabed Authority
- Representatives are volunteers
- Partial funding from ICMM
- Significant support from member employers and NROs
