

# New Board



June 18, 2012 , we renewed the board

- We have changed and improved our office and web page of the Mining Commision
- The last year, we have increased the public enrollment of competent persons by about 15%. The total enrollment is 228 people, 4% from different countries such as Peru, Uruguay, Venezuela , Cuba y Brasil.
- The admission comittee has increased from 4 to 6 people and we are improving the kind of admission questions. Furthermore, we are demanding that the sponsor letters are signed and written.
- Also, we increased our continuing education activities and publicity for the intitution, with an average attendance of about 70 to 80 people.

- We have increased interaction with government officials and our competent persons in Chile
  - For example, we have had meeting with the ministry of mining and SVS an entity that regulates the financial system in Chile.
  - We are sending emails to the competent persons with recommendations about the law as well as their obligations and rights. (with the idea to educate and inform them more).
- We formed a team to begin the modification and update of our code in Chile. (G7).
- We have developed reciprocity agreements with the U.S. and Russia (plus our already established agreements with Canada and Europe). We are still waiting on the agreements with Australia and Southafrica.
